Application Procedures

If you would like your child to go to St Peter's Church of England (Aided) Primary School, Henfield, you must complete an application through West Sussex County Council and return it online (applicants from outside West Sussex should follow their home Local Authority's application process).

In addition, any parent wishing to apply for a place for their child starting primary education at St Peter's Church of England (Aided) Primary School, Henfield should complete and return a supplementary information form. This is an important form to complete as it allows the opportunity to note under which category a place is being requested and rank accordingly when offering places. The deadline for the submission of the supplementary information form and a clergy reference form for criteria 3, 5 or 6 (see oversubscription criteria) must be submitted to the school by the national closing date for primary school applications, which can be found at www.westsussex.gov.uk/admissions

Oversubscription Criteria (extract from our Admission Policy)

- 1) Looked after children and all previously looked after children. This includes children who appear (to the admissions authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.
 - Evidence is required to support applications for looked after children, or previously looked after children who ceased to be so because they were adopted (or became subject to a residence order or special guardianship order). Where Governors are unsure about the validity of the application advice will be sought from the Local Authority's "Virtual School Head".
- 2) Children who have exceptional and compelling social, psychological or medical needs, which are supported by evidence from a doctor, social worker or other relevant professionals stating clearly why, at the time of application, St Peter's Church of England (Aided) Primary School is the only school that would cater for the needs of the child. Each case will be assessed by the Governors on its own merits.
- 3) Children from families whose home address is in The Church of England Parish of Henfield with Shermanbury and Woodmancote, where at least one parent is committed to regular worship at St Peter's Church, Henfield, St Giles' Church, Shermanbury or St Peter's Church, Woodmancote over 12 consecutive months prior to submitting the application and have a sibling who will be in attendance at the time of entry to the school.
- 4) Children who already have a sibling or siblings who are attending the school in the term for which a place has been applied for.
- 5) Children from families whose home address is in The Church of England Parish of Henfield with Shermanbury and Woodmancote where at least one parent is committed to regular worship at St Peter's Church, Henfield, St Giles' Church, Shermanbury or St Peter's Church, Woodmancote over 12 consecutive months within the determination year.
- 6) Children whose families attend worship at a Church, that is a full member of the Churches together in Britain and Ireland or of the Evangelical Alliance, where at least one parent is a committed to regular worship over 12 consecutive months within the determination year and whose home address is in The Church of England Parish of Henfield with Shermanbury and Woodmancote.
 - In the event that during the period specified for attendance at worship the church has been closed for public worship and has not provided alternative premises for that worship, the requirements of these admissions arrangements in relation to attendance will only apply to the period when the church or alternative premises have been available for public worship.
- 7) Children from families whose home address is in The Church of England Parish of Henfield with Shermanbury and Woodmancate
- 8) Any other children whose families make an application

In the event that during the period specified for attendance at worship the church has been closed for public worship and has not provided alternative premises for that worship, the requirements of these admissions arrangements in relation to attendance will only apply to the period when the church or alternative premises have been available for public worship.
